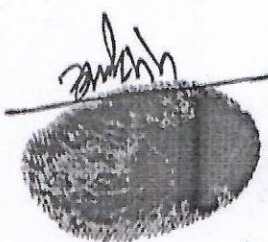

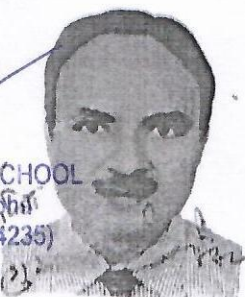

3. To open, establish, promote, setup, run, maintain, assist, finance, support and or aid or help in the setting up and or maintaining and or running Primary Schools, Elementary Schools, High Schools, Higher Secondary Schools, Colleges, other establishments and institutions for advancement of educational and the knowledge in similar.

17. 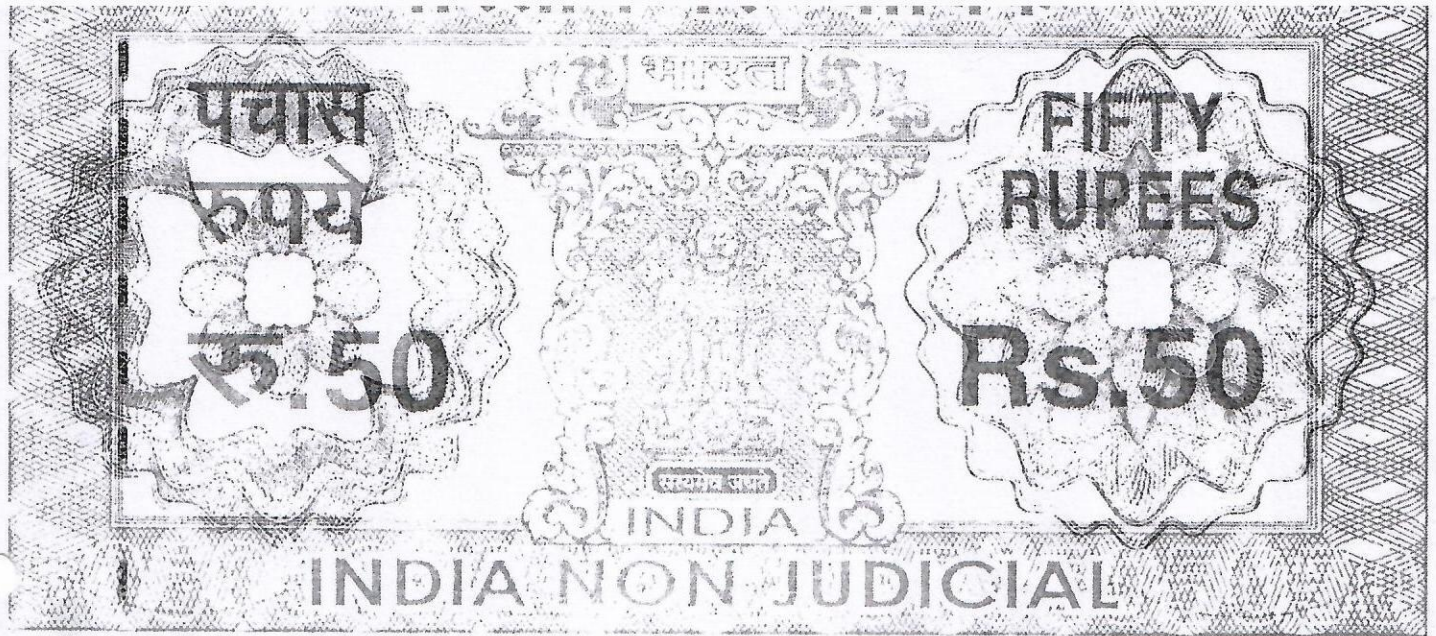
3. NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:-

1. 2. The Trustees hereby declare that they will hold the said sum of Rs 10,000/- (Rupees Ten Thousand only) handed over by the Author of the Trust to the Trust as aforesaid and the Trustees are also empowered to receive all gifts, contributions, subscriptions, donations and other monies or properties and to apply the same for the same purpose of advancement of Charity, Education, Rural Development, Environmental, Medical and Agricultural Development and other objectives contemplated in the object clause of this Trust.
3. For the furtherance of all or any of aforesaid objectives of the Trust shall have the power to organize collection and to raise funds through its Trustees for carrying out the activities of the Trust, by way of donations in India or in Foreign Countries in furtherance of aim and objectives of the Trust.

4. APPLICATION OF INCOME:

[a] The Trustees declare that the whole or any part of the income of the Trust, or the Trust Fund, or accumulations thereto, to any one or more of the objects of the Trust, as the Trustees may, in their discretion, deem fit from time to time.

[b] It shall be absolutely in the discretion of the board of Trustees to decide from time to time as to for which objects and purposes specified in object clause thereof the entire corpus of the Trust or net income of the Trust property or portion or portions of neither shall be utilized paid or spent by them and also to the terms, conditions, durations and the manners in which the same shall be so utilized, paid or spent subject however to the conditions that the income of the corpus of the Trust shall be spent and applied exclusively for such objects and purposes only in India.

5. TRUSTS FUNDS:

[a] Trustees may collect further contributions in cash, cheque, D.D. or kind towards its CORPYUS FUND or GENERAL FUND or CAPITAL FUND or REVENUE FUND or EARMARKED FUND or any other Specific Fund.

[b] Where the income and other receipts exceeds the expenditure of the Trust, the surplus funds may be transferred to CORPYUS FUND or GENERAL FUND or CAPITAL FUND or REVENUE FUND or EARMARKED FUND or any other Specific Fund.

[c] The income and other receipt of the Trust shall be used to defray the capital and revenue expenses of the Trust where such income or receipts are insufficient to meet the expenses the Trustees may use such portion of the CORPYUS FUND or GENERAL FUND or OTHER FUND for the purpose as may be found necessary for the attainment for the objectives stated in the object clause.

6. NAME OF THE TRUSTS AND REGISTERED OFFICE:

The Trust shall be known as "SHIVRAM SINGH (SRS) MEMORIAL EDUCATIONAL TRUST".

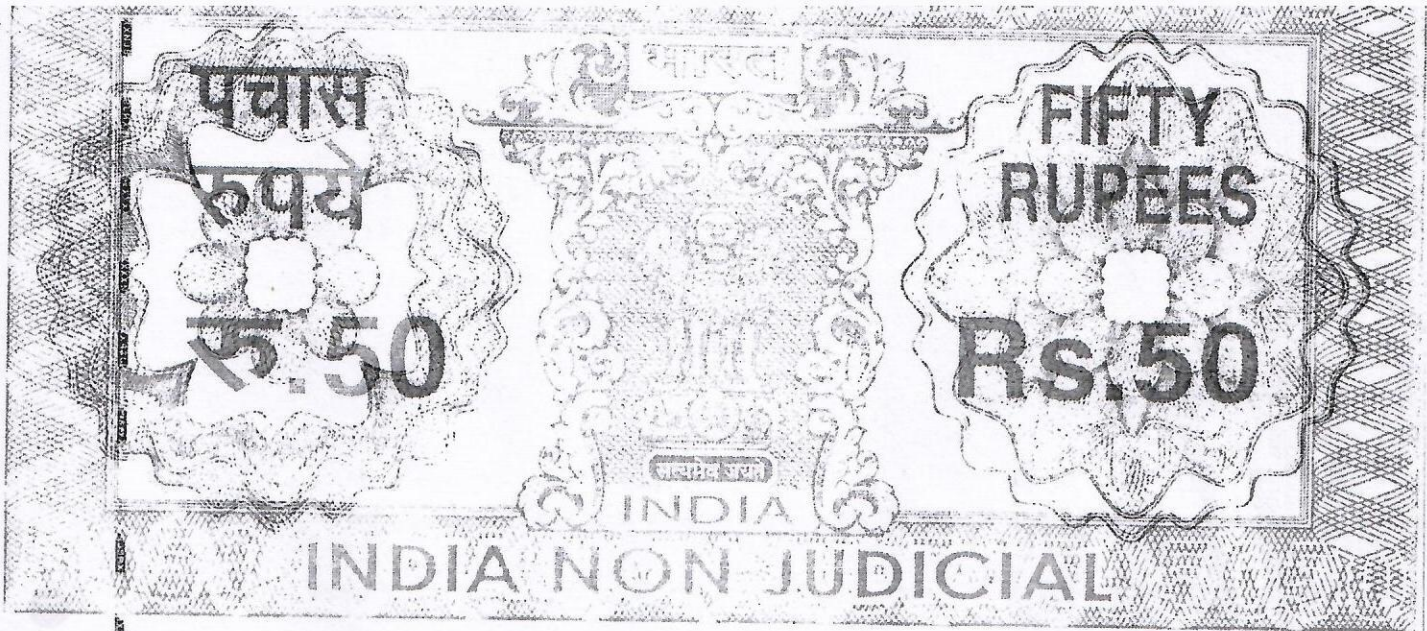

7. NUMBER OF TRUSTEES:

The Number of Trustees shall not be less than two but at the same time not more than six. The Settlor and Author shall hold office for their life time and shall not be removed by other Trustees by majority. The Founder Trustees shall hold office till they are able to attend the Trust duties. They shall be replaced only if they are or any of them is willing, unsound mind, deceased, insolvent or ordered by a Competent Court that they cannot continue as Trustees.

8. CHAIRMAN AND MODE OF SUCCESSION TO CHAIRMAN:

Mr. Gurubachan Singh, the Founder Trustee and Settlor of the Trust shall also be the Chairman in the Board of Trustees, The First Chairman shall be the Settlor of the Trust. Subsequent Chairman shall be elected by the Trustees of the Trust in a duly convened Trust Meeting by majority votes for a period of 5 years.

9. MANAGING TRUSTEE AND MODE OF SUCCESSION TO MANAGING TRUSTEE:


Mr. Virander Singh, the Founder Trustee and Author of the Trust shall also be the Managing Trustee in the Board of Trustees. Subsequent Managing Trustee shall be elected by the Trustees of the Trust in a duly convened Trust Meeting by majority votes for a period of 5 years. The same trustee can't be elected as both Managing Trustee and Chairman at one time.

10. GENERAL POWER AND CONTROL OF THE TRUST:

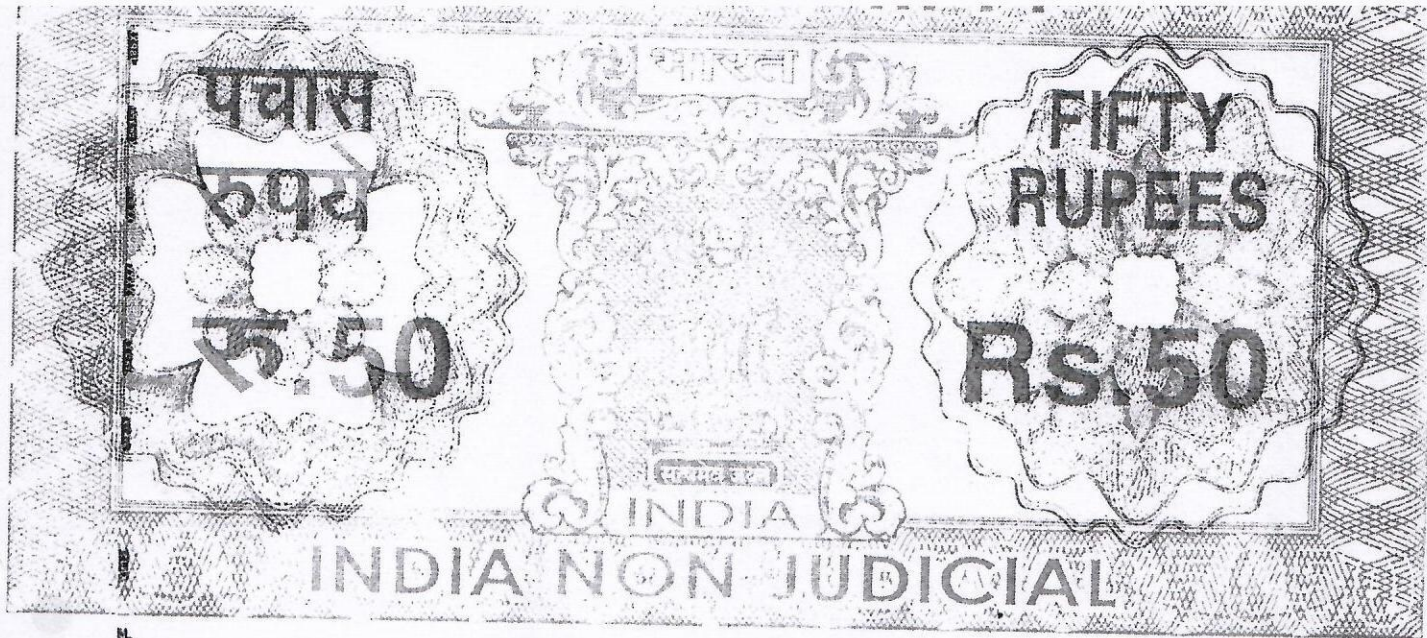
The General Power and Control of the Trust for the purpose of approval of resolutions and approval of proposals and/or recommendations of the Trust aforesaid shall be carried out by both the Chairman and the Managing Trustee. No resolution and/or proposal and/or recommendation from Trust henceforth approved by Trustees cannot be implemented without the approval of both Chairman and the Managing Trustee.

11. APPOINTMENT OF NEW TRUSTEES:

The Chairman and The Managing Trustee of the Trust may both jointly appoint a new Trustee for managing the affairs of the Trust accepting him in the Board of Trustees. Every such appointment shall be by writing under the hand of both the Chairman and Managing Trustee of the Trust. Any of the Chairman or Managing Trustee can't solely appoint New Trustee; consent of both the Chairman and the Managing Trustee is must. The Trustees hereby appointed shall hold office for the period of 3 years by rotation.

12. APPOINTMENT OF ADVISOR/MANAGER OR ANY SUCH POST:

The Chairman and The Managing Trustee of the Trust at any time can jointly appoint any person as the Advisor/ Manager or any other suitable post as recommended by the Board of Trustees for a certain and specific purpose and period of time/ years.

13. APPOINTMENT OF TRUSTEE AS A PERMENANT TRUSTEE:

A Trustee can be appointed as a Permanent Trustee of the Trust with the joint approval of both The Chairman and The Managing Trustee.

14. ACCOUNTS AND AUDIT:

Proper Books of Accounts shall be maintained in the respect of all the income of the Trust and the expenses incurred in carrying out the objects of the Trust. The accounts so maintained shall be audited by the Chartered Accountant as stated in the explanations (2) to Section 288 of the Indian Income Tax, 1901. The Financial Year of the Trust shall be from April to March.

15. BORROWING POWER:

The Chairman and The Managing Trustee jointly shall have the power to borrow money with or without interest on security of the Trust property and is empowered to alienate any part of Trust property for the benefit of the Trust.

16. INVESTMENT:

The Funds of the Trust shall be invested in accordance with the provisions of Section 13(i)(d) read with Section 11(5) of the Income Tax Act, 1961, or any other section there of as many from time to time be enacted so as to ensure that the exemption from tax in respect of the income derived from the trust fund is not loss from any year.

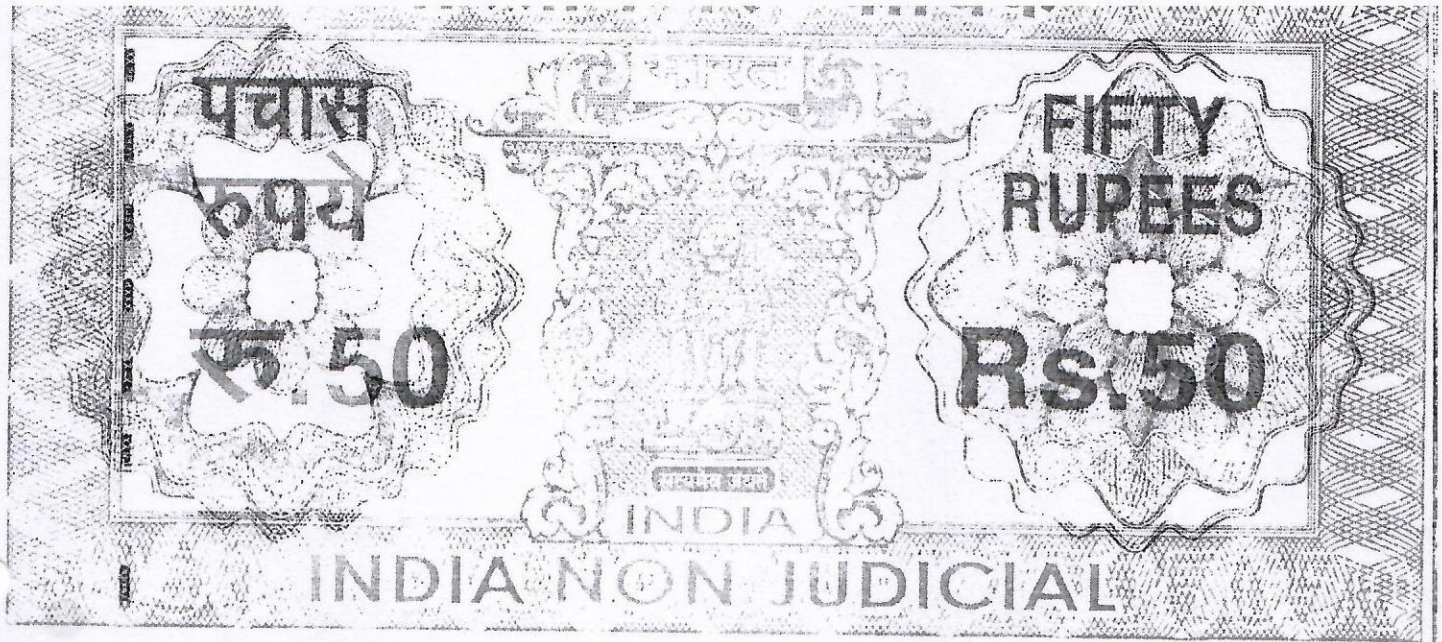
17. MEETING:

The Quorum for all the meetings of the Trustees shall be two. So long as the Settlor of the Trust is present and/ or alive, he shall be the Chairman of all the meetings of the Trustees. On the death of the Settlor of the Trust or during his absence, Managing Trustee shall be the Acting Chairman of all Trustee Meetings, but no resolution and/or proposal and/or recommendation from Trust henceforth approved by Managing Trustee cannot be implemented without approval of Chairman. The Board of Trustees Meeting shall be held at least once in every three months and at least four such meetings shall be held in every year.

18. MINUTES:

The Trustees shall keep proper Minutes Book and entered in the Minutes Book provided for the purpose, all their resolutions and proceedings and any such Minutes of any meeting of the Trustees, if purporting to be signed by the Chairman of such meeting, or by the Chairman of the succeeding meeting shall be acceptable as prima facie evidence of the matters stated. The original minutes of the proceedings of every meeting shall be deposited with the Managing Trustee who will keep the minutes in his custody.

19. APPLICABILITY:

The activities of the Trust are open to citizens of India without any distinction of religion, race, caste, sex, and place of birth or any of them and are not expressed to be for the benefit of any individual or community.

20. DURATION:

The Trust so formed shall be irrevocable.

21. AREA OF OPERATION:

At present the Trust shall operate within the jurisdiction of Amroha and Moradabad District. The jurisdiction may be extended as the Trustees mutually decided from time to time.

22. REGISTERED OFFICE:

The Trust will operate and function at Teachers Colony, Gajraula, Dist- Amroha, UP-244235. The Trustees shall have the power to shift the office to any other place of their choice.

23. BANK ACCOUNT:

Bank Accounts can be opened in the name of the Trust in any of the Nationalized, Scheduled Bank, Co-operative Banks, Rural Banks or other Banks which may be decided by the Trustees from time to time. The said account or accounts shall be operated by both the Chairman and the Managing Trustee jointly or any other Trustee duly authorized by both the Chairman and Managing Trustee jointly in writing. The Chairman and Managing Trustee jointly shall have the power to draw, endorse cheques and dividend warrants and to pay or cause to be paid to or withdraw from such account or accounts any moneys forming part of the Trust property or to close such accounts and open other accounts.

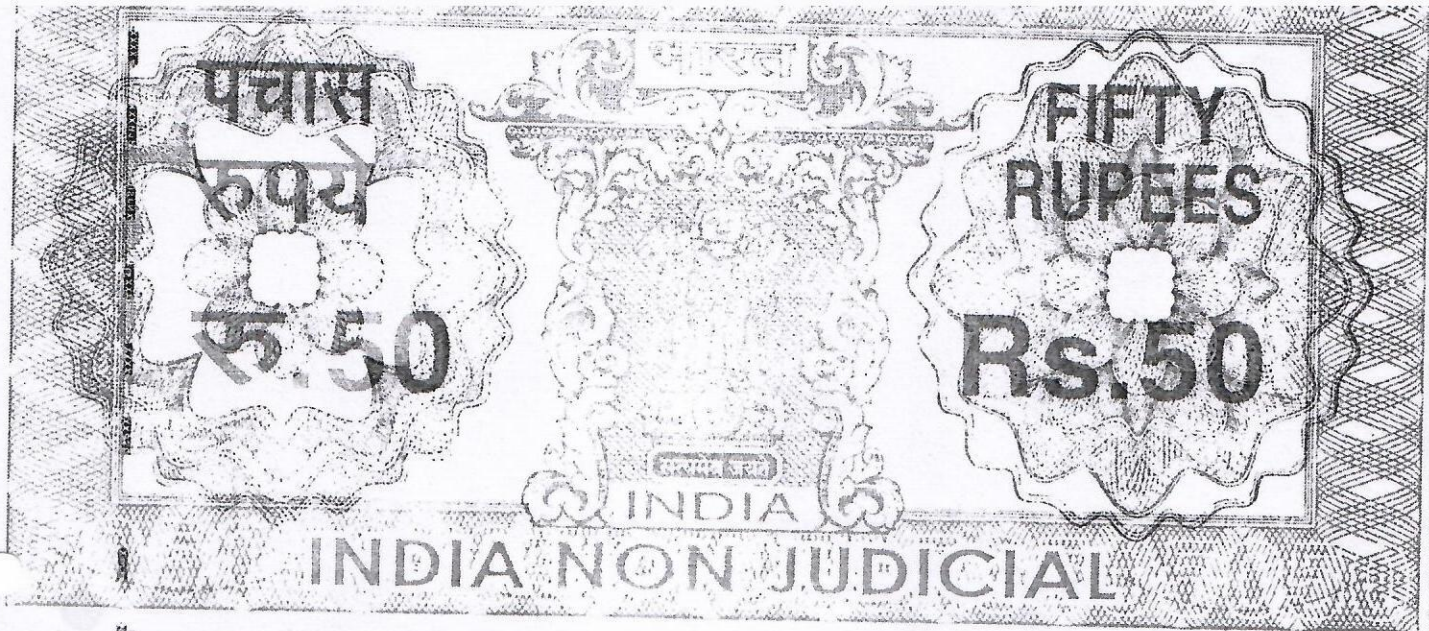

24. REMUNERATION:



25. DISCHARGE:



On account of misconduct or gross negligence on the part of any Trustee, it shall be open for the Trustees to pass a Resolution by a majority that such a Trustee is discharged and from the date of such a Resolution such a Trustee shall be considered to have been discharged.

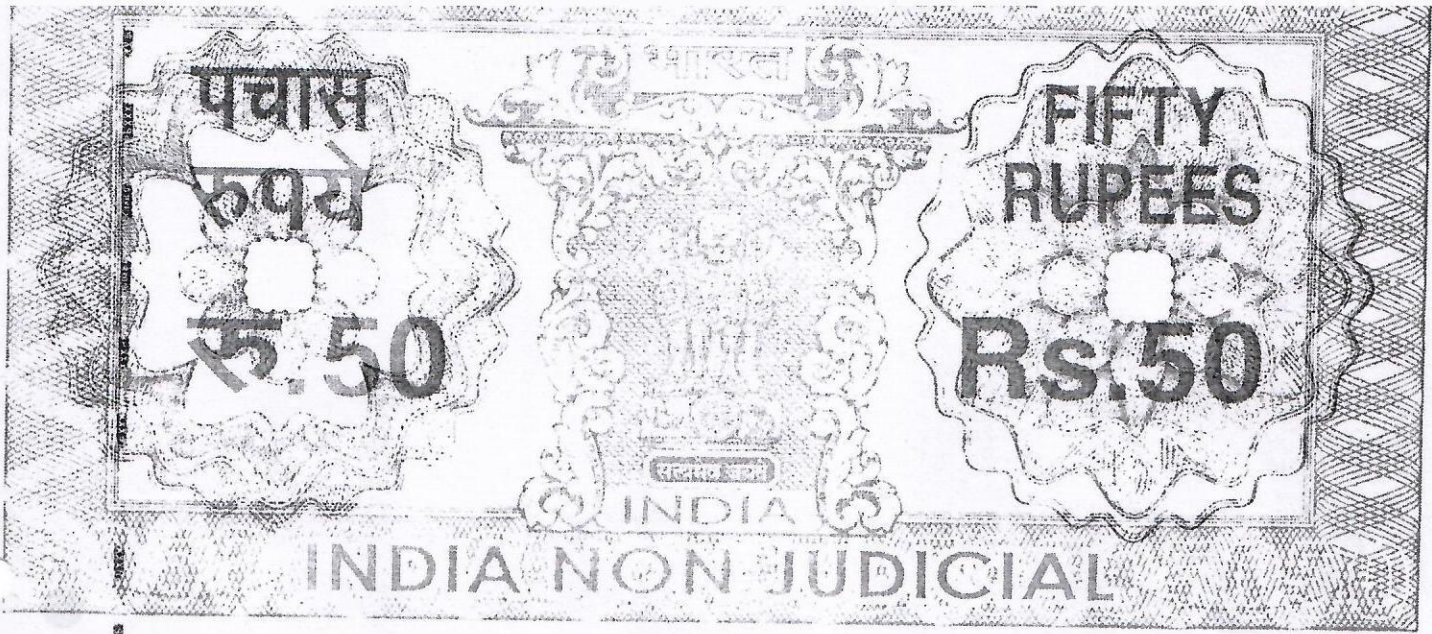
26. POWERS OF THE BOARD OF TRUSTEES:

- [i] All the Trustees shall collectively be called 'Board of Trustees'.
- [ii] The Board has power to appoint employees, teaching and non- teaching staff, and to fix their salary remuneration of such persons and the Board have full power to dismiss any of such employees in the interest of the Trust.
- [iii] A Board has power to accumulate the corpus and of the balance of income from Trust Properties after meeting the expenses of the Trust and or the institutions with liberty to Trustee to spend such accumulation of balance income for establishment and running of education and charitable institutions to carry out the objects of the Trust.
- [iv] The Board shall have full power to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the Trust Property.
- [v] The Board shall have the power to arrange for and or authorize the signing or execution of any Agreement, Contract.
- [vi] Instruments, documents or any other paper or writing required to be signed or executed on behalf of the Trust.

[vii] To purchase, take on lease or in exchange, hire or otherwise acquire any property, movables and/ or immovable's, and any right, privilege, which may be deemed necessary or convenient for the purposes of the Trust and to construct, improve, alter, maintain, lease, mortgage, turn to account movables and/ or immovable's belonging to the Trust for the furtherance of any of the objects of the Trust, subject to the sanction of the Charity Commissioner. In exercising the aforesaid powers, the Board of Trustees will observe the provisions of law.

[viii] To accept any donations, contributions, subscriptions, gifts or bequests or other transfers of disposition or property, movable or immovable's, whether subject to or not to any special condition in favour of the Trust.

[ix] To determine the mode and the manner of investment of the monies belonging to the Trust according to the law.

[x] To hear and deal with complaints, suggestions, enquiries, requests and other correspondences from the visiting public and others to the extent feasible.

[xi] To sanction recurring expenses from month to month.

[xii] To sanction expenditure on non- recurring items in a year.

[xiii] To institute, defend compromise any legal proceedings on behalf of the Trust, if and when necessary.

[xiv] To invest the surplus and other funds of the Trust according to the provisions of law.

[xv] To appoint, suspend, fine or dismiss any of the servants and employees of the Trust paid or honorary.

[xvi] To prepare annual administration report and balance sheet and to call annual or special meetings.

[xvii] To raise fixed deposits from parents, guardians, social organizations, charitable trust, private organizations etc. whenever and wherever available to realize the objects of the Trust with approval of the Managing Trustee.

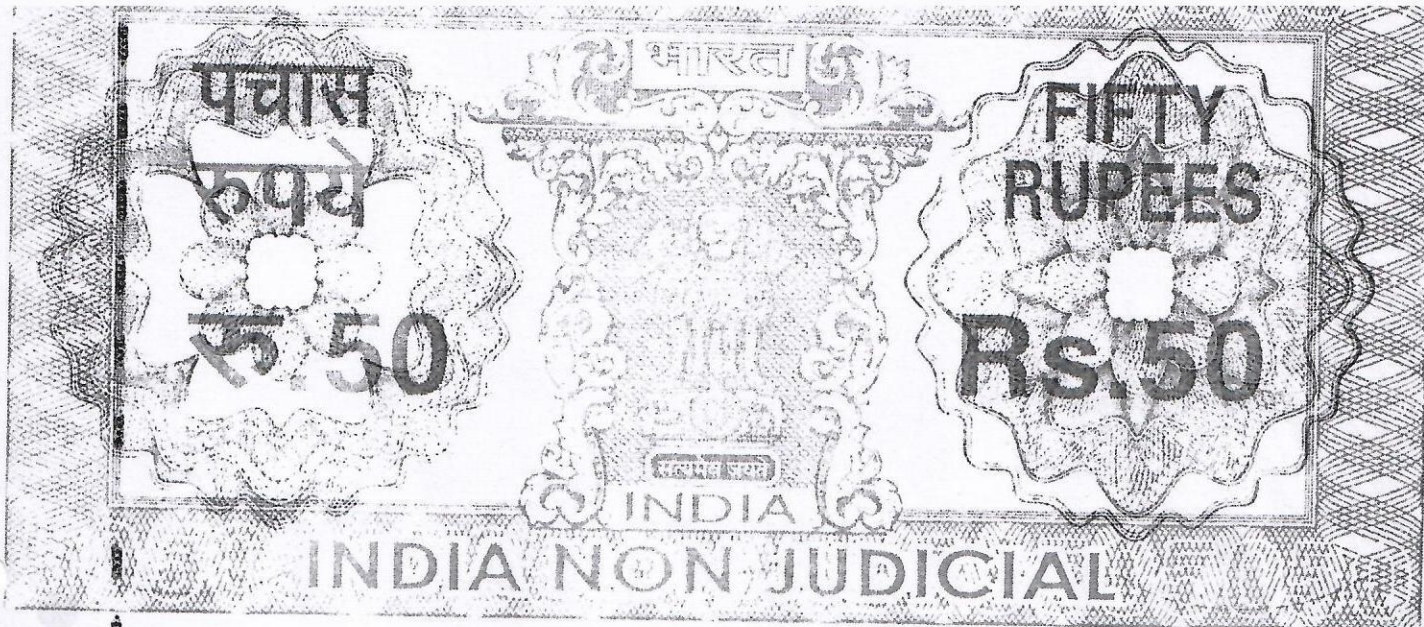

27. DEATH OF A TRUSTEE:

The office of a Trustee falls vacant on his death. It is hereby agreed and declared that if and so often as any of the Trustee hereby appointed or any future Trustee shall die or shall retire from the Trust, the new Trustee or Trustees can be added by the Chairman and Managing Trustee jointly.

28. RETIREMENT OF A TRUSTEE:

A Trustee generally retires from his office in following circumstances:

- [a] on extinction of Trust;
- [b] on completion of his duties under the Trust;
- [c] on completion of his term of office;
- [d] voluntarily retirement.

29. REMOVAL OF A TRUSTEE:

A Trustee may be removed from his office on the following grounds:

- [a] If a trustee becomes unfit or personally incapable to act in the Trust.
- [b] If found guilty of:
 - i. Misconduct or abuse of office;
 - ii. Acting dishonestly or fraudulently;
 - iii. Misappropriation of Trust Funds;
 - iv. Moral turpitude;
 - v. Application of Trust property to private purposes etc.

A Trustee can be removed by proper judicial proceedings. A Trustee found guilty of misbehavior can be removed by the Board of the Trust.





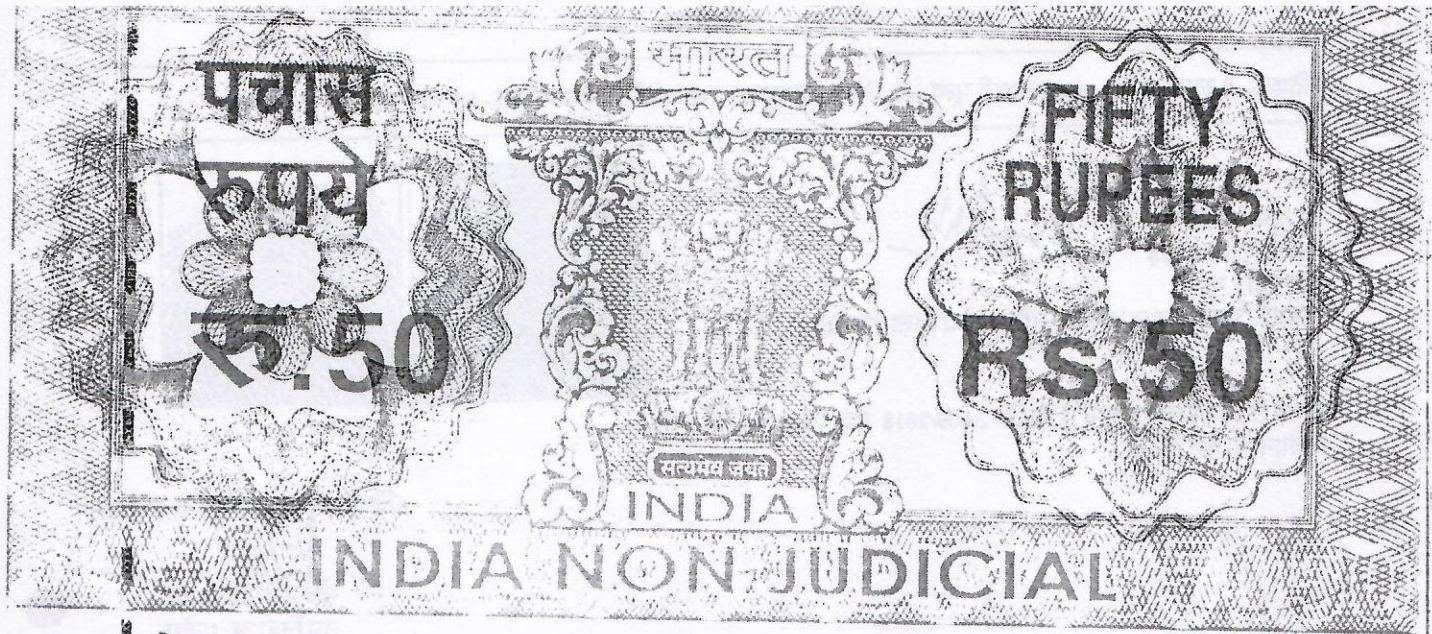

30. RIGHTS OF THE TRUSTEES:

- i. Each one of the Trustees shall have the free access to the Books of Accounts and other papers relating to Trust property and the same shall be kept in custody of the Board of Trustees. All records, Minutes Books, Title Deeds, Securities, Account Books, Vouchers, Papers and documents relating to the Trust shall remain in the custody of the Board of Trustees.
- ii. Board may reimburse trustees or pay or discharge out of the Trust Property all expenses property incurred in or about the execution of the Trust or the realization, preservation or benefit of the Trust Property.
- iii. All the Trustees are entitled to have the accounts of the administration of the Trust Property examined and settled.
- iv. In addition to the powers conferred expressly by this instruments the Trustee may do all acts which are reasonable and proper for the realization production or benefit of the Trust Property so as to the attainment of the objective of the Trust so formed.

31. MODE OF INCOME:

The incomes of the Trust may be in the form of Gifts, Contributions, Subscriptions, Donations from the public, parents, Members of the Trust etc. and may include grant-in-aid from State or Central govt., Local authorities and Charitable Institutions and other organizations.



32. ACCUMULATION OF INCOME:
